event.

Parents are to park in P3 and P4 on the south side of the lake and walk their

child to the grandstand area to meet their teachers.

Please note: parents are not permitted to sit in the grandstand - this is

reserved for competitors only. Athletes will be able to leave upon

completion of their event.

If your child successfully gains a place in the Sydney West Cross Country Team, you will be required to purchase a Zone shirt or singlet (depending on what your child would prefer to run in) for \$30. Please note that this payment is <u>cash only</u>.

Athletes are asked to stay in their school area in the grandstand. When your child completes their race, they will need to line up and follow the line to the finishing area so that their place can be recorded. They are often exhausted at this point and find it difficult to listen to instructions from staff and parents. We have first aid set up near the finishing line should any athlete require it. Once we have recorded your child's place, they will be directed back to the school area.
